



ToothFairy – Customer Experience Management (CXM)

ToothFairy LP, is a HealthTech company that provides customer experience management software for dental practices. The company was planning to handle protected health information (PHI) and recognized the need to build and maintain a HIPAA security program and ensure that their team was building compliant solutions.

Challenges

While building a new software offering, ToothFairy was navigating HIPAA compliance and developing a cloud security while trying to build a continue key product development activities.

The company saw the importance of creating a robust security program but had limited bandwidth to develop a program from scratch.

Initially ToothFairy evaluated several solutions but determined that these solutions were administrative and did not provide any controls for their cloud provider, Amazon Web Services (AWS).
